- The nominations that are most likely to succeed are nominations that address what the officer has done to improve traffic safety in their community through an approach that addresses the "3 E's" (Enforcement, Education, and Engineering").
- Other characteristics will be considered as well:
  - Events that involve extraordinary heroism
  - Extremely high or unusual level of output or enthusiasm in any of the "3 E's"
  - Undertaking new tasks or starting new programs
  - High-profile events
