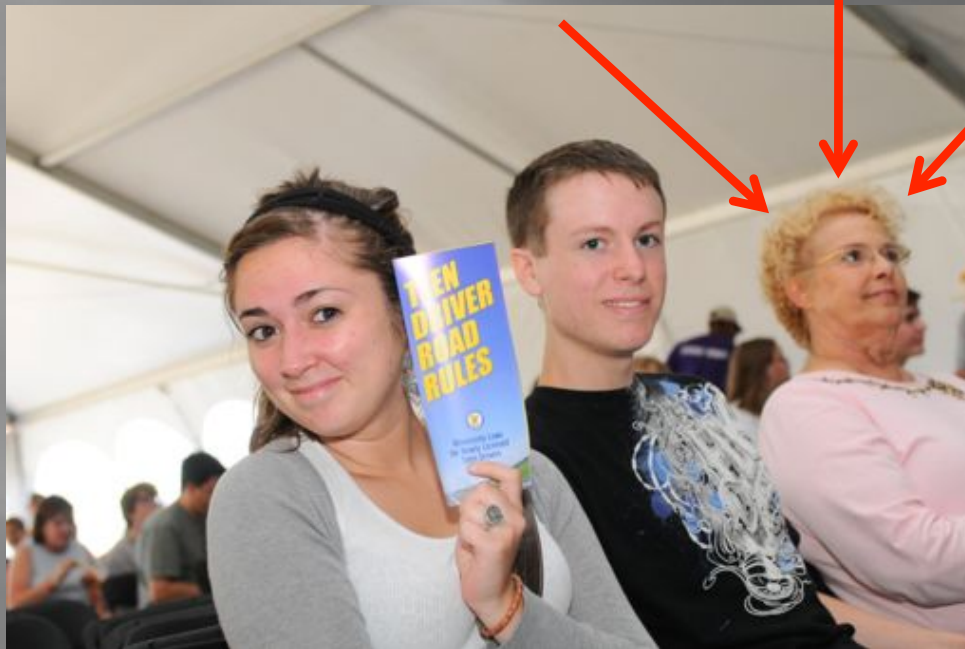

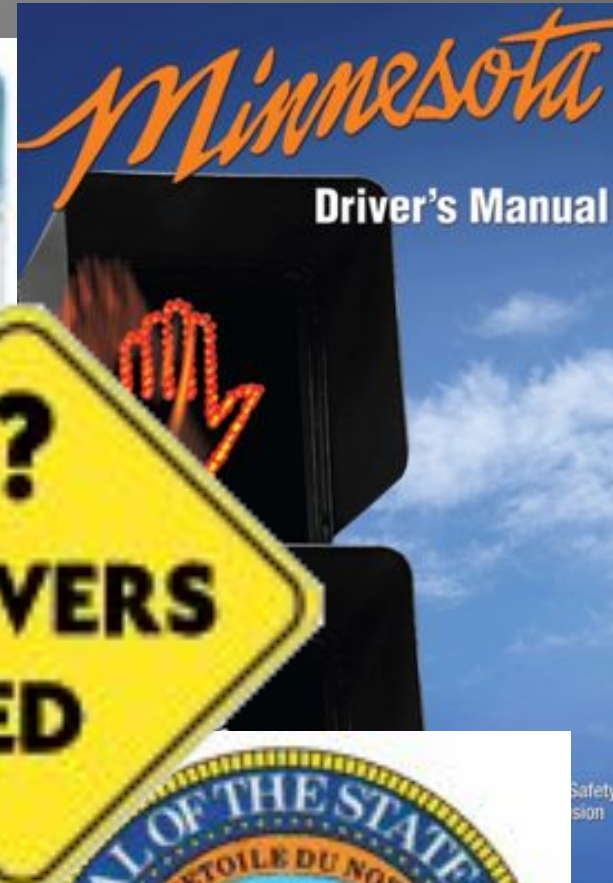

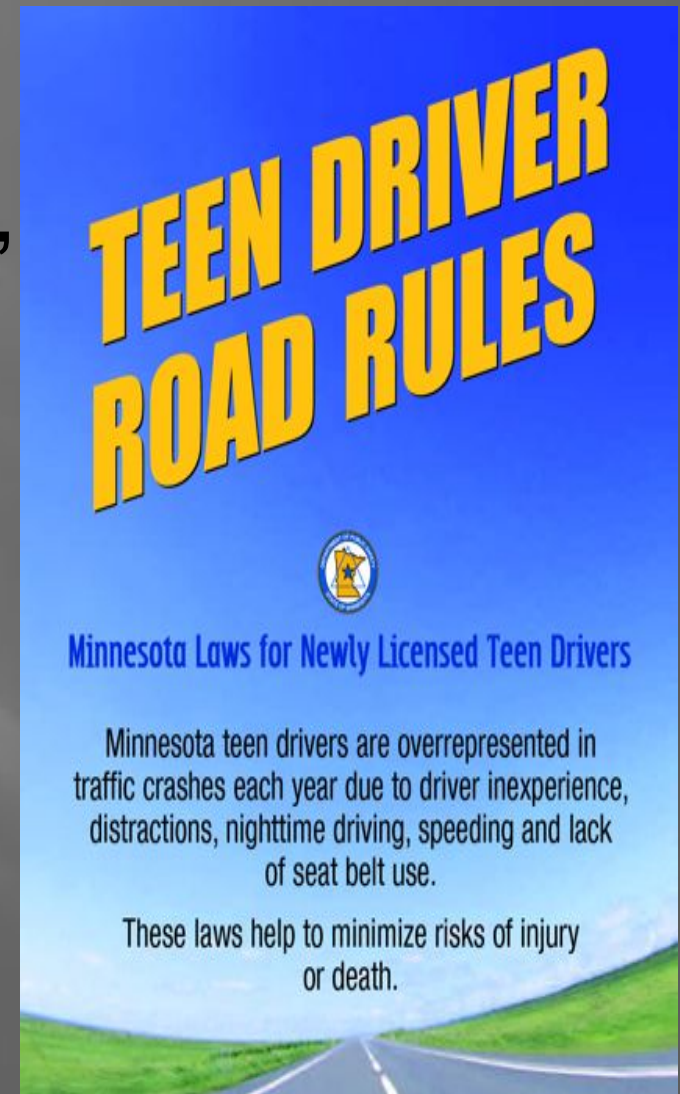

A. Withdrawal of Parental Consent / Voluntary Surrender

- I am requesting that Driver and Vehicle Services **cancel** the driving privileges of the above-named child, who is under age 18.
- I am over age 18 and voluntarily request **cancellation** of my driving privileges.

B. Reinstatement

- I request that the driving privileges of the above-named child, who is under age 18, be reinstated. I understand that he or she may **not** operate a motor vehicle until receiving written notification from Driver and Vehicle Services that driving privileges have been reinstated.
- I am over age 18 and request that my driving privileges be reinstated. I understand that I may **not** operate a motor vehicle until I receive written notification from Driver and Vehicle Services that my driving privileges have been reinstated.

I have read and fully understand the procedures for canceling and reinstating the above-named child's driving privileges. I have informed him/her that s/he may not operate a motor vehicle until receiving from Driver and Vehicle Services written notification that his/her driving privileges have been reinstated.

I also state that I am the parent/guardian who signed the application originally granting consent to drive, or who signed the Withdrawal of Parental Consent/Voluntary Surrender form canceling the driving privileges of the above-named minor child.

Teen Driving Contract

I, _____, agree to the stipulations stated below granting me the privilege of driving. If at any time I violate this agreement, my driving privileges will be forfeited for a time to be determined by my parents.

- I will always have my driver's license, car registration, and insurance card in the car when I am driving.
- Should I get a traffic ticket, I agree to pay for the ticket and traffic school, as well as the difference in the insurance premium for as long as the premium is in effect.
- At no time will I ever drink alcohol and drive, nor to any alcohol or drugs allowed in the car.
- Already in one with drugs or alcohol can ride in my car. If I am driving and they are in my car, it is as if I am in possession of drugs or alcohol. They must either change, or I can wait with them until someone else picks them up.
- I will call, any time of the day or night, my parents or another trusted and responsible person for help in getting home if I am not able to drive both safely and legally. The person called will come and get me immediately. If I call a taxi and cannot pay for it, my parents will pay for it. Making the intelligent and responsible phone call will not result in the loss of driving privileges or other punishments.
- Nobody else is allowed to drive my car unless my parents give their permission. I will not drive someone else's vehicle unless I have prior permission from my parents, or unless it's an emergency involving serious illness or injury.
- When I have passed the provisional period of not taking passengers in my car, I will be able to drive friends in my car. Their items are in my hands.
 - No smoking.
 - No spending.
 - No playing music so loud that I can't hear others.
 - Every one has to have their own seatbelt.
 - Pay attention to the roads and the traffic.
 - If my friends cannot behave in the car, they must get out.
- I will not drive until all passengers and I have buckled up.
- I will not have cell phone conversations, dial my cell phone, or send or read text messages while I am driving. I can answer the phone when I am stopped, but I need to tell the person I will call them back once I begin moving. I will safely pull over if I need to use my cell phone.
- I agree to pay the full cost of all damages that result from an accident for which I was responsible. These include damages that are not covered by insurance, as well as the difference in insurance premiums that may result from any accident.
- I will keep the car clean, inside and out, and be aware of needs for gas, oil, and general repairs.
 - I am responsible for noting that the car gas tank does not fall below a quarter full.
 - I am responsible for washing the mileage on the car and letting my parents know when maintenance appointments need to be scheduled.
 - I am responsible for paying attention to the car – listening for odd noises and checking the headlights, oil and brake lights, tires, and the oil and coolant levels.
- Carlow is _____ on weekdays, and _____ on weekends.
- I cannot drive anyone else without asking my parents for permission. If Mom and Dad are out of town but another adult is at home, those rules apply to the adult in charge.
- After school, I will come straight home. If I want to go anywhere else, I will let Mom or Dad approve of my plans. If I can't reach them at home or on the cell, I can have a message.
- I know that my parents will always love me and accept me – even if I make a mistake. I also recognize that this love and acceptance require me on both of those to respond to my driving privileges if either fail to be warranted.
- I accept that my parents have more experience than I do on the road and we'll both have to and carefully consider the advice that I am given.

I have read the above agreement and sign it in accordance with the rules.

Positive Parenting is Ideal

POSITIVE PARENTING

is warm, supportive and encouraging while being firm, consistent and clear with limits and boundaries.

- HIGH** Nurturance
- HIGH** Expectations
- HIGH** Respect

"I'm important in my teen's life. We have some good times & some bad times, but I'm there for the long run."

DOMINATING PARENTING

is harsh, punitive and rigid.

- LOW** Nurturance
- HIGH** Expectations
- LOW** Respect

"I need to really clamp down now that he's a teen.. If you give him an inch, he'll take a mile"

PERMISSIVE PARENTING

is inconsistent enforcement of rules, or no rules at all and a need to be a pal, more than a parent.

- HIGH** Nurturance
- LOW** Expectations
- MODERATE** Respect

"I really want to enjoy parenting my teen. It's important for them to fit in & have what they want, & not have too many rules. We get along better that way."

UNENGAGED PARENTING

is inconsistent presence in a child's life - teens raise themselves.

- LOW** Nurturance
- LOW** Expectations
- LOW** Respect

"It's time to let go now that my child's grown up. It's time to get my needs met. He can take care of himself."
